of the area. There should be annual inspections on these properties. She added that a lot of these properties are classified "seasonal" on the tax rolls.

The Solicitor will be looking into drafting up the following Ordinances:

- Tractor Trailer parking, not within 25' of an intersection or residential driveway
- Noise
- Rental registration
- Requiring inspections of rental properties
- Hotel tax (out of state/county/township)
- Sewer fee schedules
- Short-term rental properties not allowed in R-1

Jan Gimbi asked for an update on the property discussed last month allegedly being leased to the government as a half-way house. Residents have been speaking with the people at the property, and the occupants are just a normal couple looking to live closer to family.

Sheri Petrovich asked if Keith Wheeler has investigated the Hickory Hills blighted property issues originally given to Andrew. Georgiann stated that she would check on it.

A resident asked where to find lake access. Further discussion showed that the original access has grown in. Ownership of the lake was questioned.

Mike Spock talked about catch basins on Fern Street. He talked about using the new air packs.

Residents asked for an update on the windmill issue. No decision has been made yet.

A resident asked about the entrance to Sheaman Road at 940. Georgiann stated that it is a State road.
