

FOSTER TOWNSHIP RESOLUTION NO. 3 of 2023

**A RESOLUTION OF THE MUNICIPALITY OF FOSTER TOWNSHIP, APPROVING THE TRANSFER OF RESTAURANT LIQUOR LICENSE NO. R11074 FROM OLD BEIJING RESTAURANT, INC. KINGSTON TOWNSHIP, PENNSYLVANIA INTO FOSTER TOWNSHIP, PENNSYLVANIA.**

**WHEREAS**, Act 141 of 2000 ("the Act), which amends the Commonwealth's Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code, if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

**WHEREAS**, the receiving municipality issues a resolution approving the transfer of the license from outside the municipality to inside the municipality; and

**WHEREAS**, amendments to the Liquor Code stipulate that, prior to adoption of a resolution by the receiving municipality, at least one hearing is held for the purpose of permitting interested parties to state their concerns regarding the transfer of a Liquor License into the municipality.

**NOW, THEREFORE, BE IT RESOLVED**, that Sona Mart, Inc. has requested the approval of the Board of Supervisors of FOSTER Township for the proposed transfer of a Pennsylvania Liquor License to its facilities located within FOSTER Township, Pennsylvania, with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

**BE IT FURTHER RESOLVED**, that FOSTER Township finds that the transfer of a Liquor License by Sona Mart, Inc. will not adversely affect the welfare, health, peace, safety and morals of the municipality or its residents; and


**BE IT FURTHER RESOLVED**, that FOSTER Township approves, by adoption of this Resolution, the proposed transfer of a Restaurant Liquor License to Sona Mart, Inc., to be located at 903 Hazle Street, Foster Township, Luzerne County, Pennsylvania 18224; and


**BE IT FURTHER RESOLVED**, that the license transfer is subject to approval by the Pennsylvania Liquor Control Board.

**WE HEREBY CERTIFY THAT** this Resolution was adopted after a public hearing held on March 8, 2023, by the FOSTER Township Board of Supervisors at a public meeting following the public hearing held on the same date of March 8, 2023 at which no one from the public objected to the transfer.


