**BUSINESS:**

**Engineers Report** – Tom that as of right now there isn’t much going on, everything with the grants is in limbo and he is waiting until the spring to see what can be done with the Dawson alley. Jerry stated that John and himself would like to get together with Tom at the start of spring to go over some roadwork.

**Sewer Report** – Attny Mills stated the RFB process is still on going, but would like to ask the board to continue the meeting until 1/20 to finalize the bidding process. Jerry stated that he did received an email from Mary Beth about the high volume at the Hickory Hills station during the last big rain storm. He stated that they were able to take care of it and everything was reported to DEP correctly. He has not heard from FMA regarding high volume from the rain event on this end as of yet.

**Solicitor’s Report** - Attny Mills stated that there isn’t much going on except for the RFB’s. She did inform the supervisors that the latest case that Ms. Rahman appealed to the PA Supreme Court was rejected and sent back, therefore they can proceed with taking further action against her.

**CORRESPONDENCE**

Jerry announced that there was correspondence received, but Attny Karpowich would like to address the issues in the letter. Unfortunately, he was unable to make it to tonight’s meeting, but will address everything, including correspondence from Mr. Petrick from the previous meeting, at the January 20<sup>th</sup> continuance. Jerry did address the concerns regarding the police coverage. He stated that when he first became supervisor everyone seemed to be alright with the coverage that the State Police was giving to the twp. Since then, he has received multiple complaints and concerns regarding their coverage. He would like to at least try this coverage out for a year and to see how the twp benefits from it. If it turns out to not help the twp at all then we can terminate the contract, but he would really like to see it through for at least a year. John and Georgiann agree.
