Sewer Report – Attny Karpowich stated that the RFQ process has moved on to the due diligence period and he plans to have it out for bid by next month and then hopefully have the bids back by late October early November. The FMA complaints about the I & I are on going but the twp has to wait for a rain event to investigate.

Solicitor’s Report - Attny Karpowich reported that the supervisors had an executive session prior to the meeting in regards to possible litigation and a response that is needed from the twp. Jerry made a motion to send a response. Georgiann seconds the motion. Roll Call was Yes by all. They also discussed the bidding process for the sewer.

Zoning Report – by Georgiann: 5 zoning, 3 building and 1 stormwater permit was issued. Township checks were done with additional complaints regarding high grass and property maintenance. The hearing for Robert & Stephanie M took place and they were given an additional 30 days. Violation notices were sent to Bradley M for high grass, Fausto B swimming pool with no permit and Chris S noise & dirt track. Complaint request being addressed for Merri D.
