RESOLUTION NO. 4 of 2017**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF
FOSTER, COUNTY OF LUZERNE, COMMONWEALTH OF PENNSYLVANIA,
DECLARING THAT CERTAIN ROADS IN THE TOWNSHIP HAVE BEEN USED
FOR PUBLIC TRAVEL AND MAINTAINED AND KEPT BY THE TOWNSHIP FOR
A PERIOD OF AT LEAST 21 YEARS PRIOR TO THE DATE OF THIS
RESOLUTION**

WHEREAS, Foster Township has maintained and kept in repair certain roads more specifically described in a Deed dated August 22, 2016 and appearing of record in Luzerne County Deed Book 3016 at page 157954;

WHEREAS, the roads consist of Lakeside Road, South Sheaman Road, Valley Drive, and Sunrise Lane located within the Ag-Mar Estates Development in Foster Township, Luzerne County, Pennsylvania (the "Roads");

WHEREAS, the Roads have been used for public travel and maintained and kept in repair by the Township for a period of at least 21 years prior to the date of this Resolution and prior to the date of filing of a civil action to quiet title the Road at Luzerne County Court of Common Pleas Term No. 5317 of 2016;

WHEREAS, a Final Judgment was entered to the civil action to quiet title the Roads on August 22, 2016, wherein the Township was declared to be the owner and caretaker of the Roads;

WHEREAS, Foster Township has also been maintaining the extension of Highland Heights Road in the Highland Section of Foster Township for a period of at least 21 years prior to the date of this Resolution;


WHEREAS, pursuant to 53 P.S. Section 67307(a) of the Second-Class Township Code every road which has been used for public travel and maintained and kept in repair by the Township for a period of at least 21 years is a public road; and


NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Foster Township that this Declaration is being made to satisfy the Pennsylvania Department of Transportation (Penn Dot) for the purpose of obtaining liquid fuels to continue the maintenance and upkeep of the Roads in specified herein.


